Old Business:

Smith Cemetery access

- Lawyer to make a record regarding motion made during a Trustees telephone conference on February 27th, 2020 for the purpose of approving the expenditure of \$850.00 to Warren County Abstract for the purpose of a title and easement search for all three Township Cemeteries, Smith Road, and survey for any additional properties deeded to the Squaw Creek Township between the founding of the township and 1900. The matter was put to a vote which was unanimously approved. Attendees: Jandik, Lawyer, and Jandik.
 - Lawyer requested a motion that the above telephone record was accurate. Willis so moved, unanimously approved. Motion Carried.
- The Trustees had possession of copies of deeds for Smith and Indian Valley Cemeteries that were provided to Warren County Abstract. Concerns with historical deeds to the Trustees are they are in the names of the Trustees for the Township, however, that provides challenges during research as the names of the Trustees during that time are unknown. Additionally, the Township records are not recorded by alphabetical order but by section, of which there are 36 in Squaw Creek.

 - o Survey Smith Road, Mt. Tabor Cemetery, and Smith Cemetery
 - o Initiate Quiet Title
 - o Any additional necessary steps with Smith Cemetery Access

Review/Discuss and Potential Action Cemetery Rules

- Updates from Jandik:
 - Warren County Recorder's Office is stating that the Certificate of Internment Rights is not acceptable and the document needs to be a Cemetery Deed.

- Lawyer According to State Law, a Certificate of Internment is allowable and is recordable. He will reach out to the Recorder's Office to have a conversation, and will locate the statutory documentation.
- Jandik Last recorded documents were in 2017 on a Certificate of Internment Rights.
- Howe Will bring Certificate of Internment Rights for Recording.
- The existing Internment Rights there are not 'unique' identifiers that need to be included going forward. #4, rules are not documented for opening and closing services, #6 in the rules is not included in the Internment Rights.
- o Jandik to email a copy of Jasper County Rules Book to Trustees.
- o Trustees to consider updating the traffic path within Indian Valley.
