CALL TO ORDER - Chairperson Steven Lawyer motioned to open and call to order the meeting at 1:26 p.m. Second by Jandik. Ayes: All. Motion approved.

Jandik also shared that Marty of Indianola Memorial Works will be setting headstones for the Sheeders and the Haucks. No burials have occurred yet for the Haucks, so she and Steven will do measurements and place flags for where the stone needs to be placed.
- 3. Smith Cemetery Access Jandik reported the Warren County Board of Supervisors meeting she and the Clerk attended was successful. Tim Hill, Assistant Warren County Engineer will assist with grading of 108th Avenue and will be present for the spreading of rock. The township will be responsible for acquiring the rock. The Clerk will facilitate purchase of rock. Clerk will also work with Tim Hill to create a timeline of events for grading and rocking and report to the Trustees. Jandik will notify the Carpenters of the date(s) work will be done.

NEW BUSINESS

1. Flag purchases for 3 cemeteries – Trustees discussed purchasing quality flags to have on hand so flag replacement at the cemeteries would be quicker in the future.
