Old Business:

Smith Cemetery access

 Abstract Company – Lawyer spoke to Abstract company, and the individual has been severely injured and is unable to complete the requested objectives. Per the Abstract Company, since we are a Township, the Recorder's office will complete the research necessary (easements, legal descriptions, deeds, etc.) to complete required work. This work will be done at no cost.

Review/Discuss and Potential Action Cemetery Rules

- Lawyer Provided hard copies to those in attendance.
- Mostly minor changes Please review and provide feedback.
- Major change that will impact Internment Rights: The rules were getting confusing because 'rights of internment' would also include 'inurnment'. Lawyer is proposing to update the 'Certificate of Internment Rights' to 'Certificate of Burial Rights' and updated the language throughout the Cemetery Rules. Additional updates include a naming convention for plot names for each Cemetery within the Township. Further, if the purchaser of the plots decide to change WHOM will be buried, changes will be required through formal documentation. Several other updates are within, and feedback is required.

Discuss Flag Poles and Eagle Scout Project

- The Eagle Scout Project has been approved by the Scout Master (Rich Keller).
- A 25' internal rope pole will be less than the previously approved \$1,500. Concrete costs will be approximately \$3,500 per pole. Additional costs would be the Flags, sleeves, gravel, and potentially labor.

- The full project consists of the purchase and installation of the flagpoles at all three Cemeteries.
- Jandik motions to approve the Sam Lawyer Eagle Scout Proposal to include installed, illuminated flag poles with Flags and plaques at each Squaw Creek Township Cemetery with funding provided by the Township materials and equipment. Willis Second, Unanimously approved. Motion Carried.

Discuss Tree Trimming

- Jandik On hold
 - o Webb's have volunteered to do additional tree trimming

Discuss Emergency Services contract with Virginia Township

- o Jandik spoke to New Virginia City Council attorney (Stuyvesant). Future payments are to be paid to the city, not the Virginia Township.
- o As half of 2020 has surpassed, Squaw Creek Township will cut a check for the first payment in the same fashion as historical payments the last few years.
