 - iii. Proposed: Invest \$50,000 into Certificate of Deposit 20 months 3.45% interest rate /3.5% annual percentage yield

Motion made by Jandik to close the savings account which consists of approximately 36,000, plus any interest and move to the checking account. Then to move all monies which should consist of 133,698.65 plus any interest to a Business Cash Management Account. From that account, our clerk has authorization to move \$50,000 into an interest-bearing CD for 20 months at 3.45% interest rate/3.5% APR. After some discussion, a motion was made to also have our clerk move \$50,000 to an interest-bearing account called a Companion Savings which will provide an interest rate of 1.095/ 1.10apr. This account is tied to a CD, but will allow us to pull from that without penalty. This would leave approximately 36,698, plus any interest accrued for the Business Cash Management Account.
